- 14 • All requests to be excluded from the Settlement Class must be in
- 15 writing, sent to Class Counsel, and postmarked on or before the Opt-
- 16 Out Deadline, which is March 26, 2021;
- 17 • All objections and requests to appear at the Final Approval Hearing
- 18 must be in writing and postmarked on or before March 26, 2021.
